On Campus Engagement

IAEP Certificates

Internal Audit and related courses are thriving at KSU. To earn the Internal Audit Educational Partnership (IAEP) Certificate, students must complete five courses including Accounting Information Systems, Auditing and Assurance, Accounting Data Analytics, Fraud and Forensic Accounting, and Internal Auditing. We issued 93 IAEP Certificates this year. In 2023-2024, 73 students successfully completed the necessary undergraduate courses to earn the IAEP Certificate awarded by the Institute of Internal Auditors. Additionally, 20 students completed the Master of Accounting specializing in Audit/Advisory and earned their IAEP Certificate.

IA/Advisory Student Day

In September 2023, Kennesaw hosted the 18th Annual Internal Audit/Advisory Student Day and Career Fair. 26 firms and over 80 students attended the event. Five schools around Georgia were represented. 

IA Awareness Day

Kennesaw hosted the 5th Annual IA Awareness Day in March 2024. This was an opportunity for KSU students (majoring in accounting, finance or information systems) to learn more about career paths in Internal Audit/Advisory. Additionally, there were 3 other colleges represented at this event. Over 80 students heard professionals share their experiences within Internal Audit,

The Internal Audit Student Organization has continued as a registered student organization on campus. This is an opportunity for students to explore, share, and develop their interest in Internal Auditing. We have a minimum of one meeting per school year. This year our meetings took place in conjunction with the IA/Advisory Student Day and the IA Awareness Day.

Graduate Classroom Engagement

Many professionals are engaged with the MAcc audit/advisory classes. The MAcc students heard how the profession is leading in the area of Diversity, Equity, and Inclusion from Nataly Marks (KPMG), Carley Ferguson (Mohawk Industries), and Bill Stahl (Inspire Brands). Ian Almeida (Coca-Cola) and Cade Stanfield (Deloitte) judged the Internal Audit class case competition. Doug Daley (UPS) judged student presentations in the Seminar in Auditing.

Research Rankings

KSU ranks 69 overall worldwide in the past 6 years in academic publications in the top 12 journals. Within the areas of auditing and education, KSU ranks 4th in education scholarship and 20th in auditing (source 2023 BYU rankings).
