#### **Discounted Athletic Events**

All employees get discounted tickets to various sporting events including football, basketball, and baseball!



#### **Employee Fitness Center**

Access to an onsite fitness center for you and your family. Membership includes fitness coaching and group classes.



#### Tuition Assistance Program (TAP)

The Tuition Assistance Program waives tuition and most fees for employees seeking degrees at any USG institution.



#### **Faculty and Staff Meal Plans**

Plans include discounted entries to The Commons and Stingers and complimentary enrollment in the Takeout Club.



#### Art and Events

Enjoy access to free and discounted artistic functions including concerts, exhibitions and special performances.



#### Perks Program at KSU

All KSU employees are eligible for discounts offered through Team Georgia and local merchants around the KSU campuses.

## Paid Time Off

Full-time employees accrue 8 hours of sick leave time and a minimum of 10 hours of vacation per month.

Employees also receive 8 hours of Educational Support Leave each calendar year to attend academic functions supporting students in GA schools.



Employees receive 13 paid holidays per calendar year.



To help prepare for retirement, KSU offers multiple investment opportunities in addition to a state-supported pension plan (TRS).

Plans include 401(a), 403(b) and 457(b). These plans include options for pre-tax and after-tax ROTH.
