## STUDENT REFUND SCHEDULE & LATE WITHDRAWAL FEES

- ▶ The \$300 initial program fee payment is **nonrefundable** unless the program is canceled by USG Goes Global. Students who withdraw before acceptance or are not accepted may appeal for a refund. Once a student is accepted or the application deadline has passed – whichever occurs first – the initial payment becomes fully nonrefundable.
- ▶ Students withdrawing **within 35 days** of the final program fee payment deadline will owe **50% of the program fee**.
- ▶ Students withdrawing **within 10 days of or after** the final program fee payment deadline will owe **100% of the program fee**
