I. Call to Order

President George called the meeting to order at 7:08pm. Chief of Staff Knight called the roll.

They also highlight that they maintain neutrality when conducting conversation . He did touch on that they are not advocates, decision-makers, or lawyers, instead they specialize in identifying resolutions.

Senator Sonnier questioned if OMBUDS follows KSU policy? OMBUDS does not solve situations but does give suggestions.

A guest questioned how often they met with students. He answered that they have scheduled meetings by appointment multiple times a day. He is booked until October.

Director Watts questioned the sexual harassment to commitment of possible harm? He explained it depends on who is coming forward; a bystander, a person who has possibly has been harassed, or a person who committeed sexual harassment.

VII. Open Forum

A. Alex - KSU Student

- a. Resident in the Stonewall LLV, which is designed for students who may be uncomfortable or in danger due to sexual identity. They feel they would not have been able to feel safe if not for Stonewall. Received a single email 430 days ago that the center would be dissolved. Wants KSU to be more transparent and reverse policy.
- b. Director Watts questioned how they would respond when posed with the question why the village should be protected when the University is faced with a housing question. Student responded by emphasising the need for safe community spaces
- c. Senator Navrro questions if any other universities have made this change.

- d. Senator Tollerson questioned if they felt targeted as a community, and if they have looked at the DEI requirements on the state and federal level. The student said yes to both, and highlighted that no other universities have taken this course of action.
- e. Senator Eustache motioned to extend speaking time by 2 minutes. Attorney General D'Souza second the motion. The motion was passed unanimously. Time was extended by 2 minutes.
- f. Students highlighted that some students will be left with potential risk for wellbeing if Stonewall is resolved.
