G. Advisor(s) Update

- Dr. Eric Arneson
 - In 2018, there were two separate lawsuits brought by RSOs
 - Lawsuit 1: An RSO requested permission to put a pro-life/anti-abortion graphic up and thought the graphic was put in a place that was not visible; so, they believe they were being discriminated against
 - Settlement: Policies were changed so now any RSO can reserve spaces on either campus
 - Lawsuit 2: (Part 1) An RSO said that if they brought in a speaker that KSU didn't like or thought was controversial, KSU would make them pay multiple fees to persuade them from getting the speaker (Part 2) RSOs were funded differently based on favoritism
 - There were tiers based on how much activity an RSO did over the years.
 So, if your RSO hosted more programs, they were on a different (higher) funding level
 - Settlement: (Part 1) An org who hosts an event with a speaker is responsible for security, but they can request through SABAC to pay for that (Part 2) Gave all RSOs the same funding opportunities and anyone can apply to SABAC in the same manner
- Dr. Ronald Briggs
 - Need SGA's assistance on connecting with peers
 - Everyone has the right to free speech; Simply don't engage
 - Student activities has reached out to help give information about the SABAC process
