

GEORGIA NATIONAL GUARD MEMBERS & U.S. MILITARY RESERVISTS OUT OF STATE TUITION DIFFERENTIAL WAIVER

An independent student who, as of the first day of the term of enrollment, can provide documentation supporting that he or she is currently participating in active duty, stationed or assigned to Georgia with the National Guard, or is an active member of a unit of the U.S. Military Reserves based in Georgia, may qualify immediately for an out-of state tuition differential waiver. This also applies to their spouses and dependent children. The student may retain the waiver every semester after the waiver is approved provided the student remains continuously enrolled. If a student does not register for a two consecutive semesters following their last enrolled semester at KSU the waiver will be removed. If the student returns to KSU, if eligible, the student can reapply for the waiver or petition to change tuition classification.

Students will have until 30 days after the first day of the term to apply for this waiver. No applications will be accepted past that date. No retroactive changes will be considered for prior terms or fiscal years.
